4.	CBI Presentation	Grant Request	Skylar Fate
Discussion:	<ul style="list-style-type: none"> The only CBI request was from Brookings Core Response for the 2024 Point in Time Count. The request is for \$2,500. Skylar noted that Advanced Health is also contributing \$2,500. Kevin stated that we have always funded the point in time homeless count for the last four years, and that the money is definitely needed. Starla said that Coos County has been ordering supplies for the count all year long, and that if Advanced Health doesn't fund it, the AllCare CAC money could still be used. BCR would use the supplies throughout the year. The count is very important for receiving state funding.

Discussion:	<ul style="list-style-type: none"> <u>New AllCare DEI Director:</u> Regina Castellon, Director of Diversity & Inclusion Department—Regina said she has been with AllCare in this position since December, and that she hopes to attend CAC meetings as much as possible. She invited CAC members to feel free to email her. She described the upcoming training, “Being an Ally in Indian Country,” to be held at AllCare on January 17 and 18. Skylar said she will send CAC members a flier for the training, adding that it is a free, live event, and that CAC members are welcome to attend. Regina said a part of her job is looking for ways that diversity and inclusion can be interwoven into our work. <u>CCBF Funding:</u> Jennifer Gustafson, Director of Community Engagement, described how Community Capacity Building Funds fall under the 1115 Waiver and are intended to fund infrastructure needed in order to provide HRSN services. Allowable use categories for this funding stream include: technology, business development, workforce development, outreach and education. Eligible to apply for these funds are social service agencies, food providers, case management providers, traditional health workers, child welfare workers, city, county and local government agencies, outreach

	<p>and engagement providers, and providers of climate devices and services. AllCare has received a CCBF budget of \$1.9 million which will cover the four service areas. There is a tentative launch date of March 1, 2024. Contact Jennifer if you have any questions. The following link was provided:</p> <ul style="list-style-type: none"> ○ <u>https://www.allcarehealth.com/about-us/community/1115-waiver-funding-opportunities</u> • <u>Dual-Special Needs Program:</u> Hazel Clements, Vice President, Population Health, described the Dual Eligibility Special Needs Plan (DSNP) to the CAC and said they have an advisory committee for the DSNP similar to the Medicaid CACs. They would welcome new members to the DSNP advisory committee. She said the DSNP plan went live January 1, 2023, and is designed to meet the needs of folks with special medical and social needs. Assistance with medication therapy management, ReadyRide, behavioral health services, nutrition education, home monitoring, meal programs for those in transitional care, and more are available. Skylar will be sending additional information to CAC members via email.
